Whereas. A.M. College, Gaya, Plot No. 64, Vill. – Katari Hill Road, Po/Tehsil – Gaya, Town/City – Course vide order dated 17.12.2012 from the academic session 2013-2014 is fallowed by the revised order dated order dated 100 from the academic session 2015-2016.

2. AND WHEREAS, the ERC in its 266th meeting held on 31st January, 2019, after considering and examining the application along with the documents submitted by the institution, agenda note, NCTE Act, NCTE Regulations 2014 including Norms and Standards, guidelines received from NCTE Hqrs. from time to time, VTR and reply in response to SCN issued after LOI, the Committee discussed the matter in detail and observed as under:

Building plan approved by Govt. Engineer is not submitted.

- (ii) Building completion certificate approved by Govt. Engineer in the NCTE prescribed proforma is not submitted.
- (iii) Fire safety certificate issued from the competent Govt. Authority is not submitted.

(iv) Validity of photocopy and original submitted expired, need to be renewed.

In view of the above, the Committee decided as under:

Show Cause Notice be issued to the institution as to why the application for permission be not refused on the above point. The Committee therefore, provides last opportunity under section 17(1) of the NCTE Act 1993 to the institution to submit its reply within 21 days from the issue of this letter before the Committee takes final decision.

- 3. And whereas the Committee is of the opinion that the institution prima facie, does not fulfill the requirements, the norms and standards laid down by the NCTE in accordance with the provisions of the NCTE Act, 1993, as detailed above.
- 4. Now therefore, as per the Section 17(1) (b) of NCTE Act, 1993, before the Regional Committee passes the final order on your application, you are hereby given an opportunity for making such written representation within 21 days of issue of this notice along with the supporting documents.
- 5. In the event of this office not receiving representation within 21 days from the date of issue of this notice, it will be presumed that you do not wish to make any representation and the Regional Committee shall take decision as it deems fit and proper. However, if the institution has already submitted the reply in response to uploaded minutes of 266th Meeting of ERC in its Website, the same shall be treated as the reply to the decision of ERC.
