#### ORDER

WHEREAS, A.M. College, Gaya, Plot No. 64, Vill. - Katari Hill Road, PO.- Gaya, Tehsil/Taluka- Gaya, Town/City- Gaya, Dist.- Gaya, Bihar- 823001 (Code No.ERCAPP698) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2013-2014 vide ERC Order No.15378 dated 17.12.2012, followed by revised order vide No.31670 dated 15.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- AND WHEREAS, the ERC in its 270th Meeting held on 25th 26th March, 2019 considered the matter along with the reply dated 14.02.2019 in response to Show Cause Notice on the basis proceedings uploaded on ERC website, submitted by the institution and observed as under:
  - (i) Show Cause Notice u/s 17(1) was issued on 25.02.2019.

(ii) Validity of photocopy FDRs Rs.5 lakh and Rs.3 lakh in joint mode expired on 21.02.2019 but not renewed.

(iii) Total built up area in the building completion certificate mentioned as 19368 Sq. ft. i.e. 1799.34 Sq. Mis. which is less than as required under NCTE Regulations, 2014 for running 02 units (100 intake) of B.Ed. programme...

In view of the above, the Committee decided as under: The Committee is of the opinion that recognition granted to B.Ed. course of the application bearing Code No.ERCAPP698 is withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2019-2020.

- AND WHEERAS, the order of withdrawal was not issued to the institution and the matter was re-considered by ERC in its 271st meeting held on 24-25 April, 2019 under the Agenda Item No.271.1.16 before confirmation of proceedings of 270th ERC meeting held on 25-26 March, 2019.
- AND WHEREAS, the ERC in its 271st meeting held on 24-25 April, 2019 analyzed the representation vide Ref. No.Edn/184/22/04/2019 dated 22.04.2019 along with enclosures submitted by the institution on the basis of decision taken in 270th meeting uploaded on ERC website and decided as under:

Decision taken by ERC for withdrawal of recognition to B.Ed. course is rectified and the recognition be restored from the academic session 2019-2020. Accordingly, order be issued to the institution and all concerned. P.T.O.
